National Cancer Patient Experience Survey (2017)

- The NCPES survey was first undertaken in 2010
- It has been designed to monitor national progress on cancer care; to provide information to drive local quality improvements; to assist commissioners and providers of cancer care; and to inform the work of the various charities and stakeholder groups supporting cancer patients
- The survey was overseen by a NCPE advisory group
- The survey is commissioned and managed by NHS England
- The design, implementation and analysis of the survey is outsourced to quality health






Q7: Were the results of the test explained in a way you could understand?




Q9: How do you feel about the way you were told you had cancer?




Q8: When you were first told that you had cancer, had you been told you could bring a family member or friend with you?




Q12: Before your cancer treatment started, were your treatment options explained to you




Q15: Before you started your treatment(s), were you also told about any side effects of the treatment that could affect you in the future rather than straight away?













